Costs for Registration:

- Early Registration: AED 250 -Applicable from September 9th to November 17th.
- Late Registration: AED 300- Applicable from November 18th to January 12th.* *- Kindly note that registration is based on a first come- first serve basis, and that it might be closed prior to the deadline based on the number of applications received.
- Advisor Fee: For every 20 delegates, 1 free advisor is permitted. Any additional advisor will be charged a fee of AED 100.

Deadlines:

- Name changes and name amendments will not be permitted after January 12th, 2019.
- No applications will be accepted after January 12th, 2019.

General Information:

- Schools are not permitted to bring their own photographers nor observers.
- For international delegates, hotel and airfare booking is their own responsibility. However, we highly recommend "Centro Rotana Hotel" due to its close proximity to the American University of Sharjah campus. The hotel is around 10 minutes away from "Sharjah International Airport". The price range is around 300AED- 600 AED per night inclusive of breakfast.
